It is estimated that there are more than 70,000 eligible people in the Bronx who do not utilize available healthcare services including primary care and health insurance.

BPHC has partnered with seven community-based organizations (CBOs) to inform and connect Bronx residents to primary care, health insurance and supportive health services. More than 9,500 community members have been reached to date.

Behavioral Health Providers RHIO/QE Connections and Barriers Survey – 2017

The New York State Offices of Mental Health (OMH) and Alcohol and Substance Abuse Services (OASAS) are conducting a survey measuring Regional Health Information Organization (RHIO)/Qualified Entities (QE) connections and barriers. Results from this survey are important to OMH and OASAS and will be shared with local RHIOs/QEs.

New York State Behavioral Health Organizations who fall under any of these categories are asked to complete the survey:

Article 31 OMH licensed program

Article 32 OASAS certified program

Adult Behavioral Health - Home and Community Based Services (HCBS)

Children's Home and Community Based Services (HCBS)

Note, if two people from the same site fill out the survey, they must do so from two different computers.

BCC Seeking Behavioral Health Providers for Grant Partnership

Bronx Community College has two grant partnership opportunities for behavioral health service providers:

BCC Behavioral Health Opportunities Program trains community members and incumbent workers for entry-level positions at behavioral health service providers.

Students who complete the program may qualify for positions such as Certified Recovery Peer Advocate, Mental Health Peer Specialist, Peer Educator, Peer Support Specialist, Community Healthcare Worker, Outreach Worker and Care Coordinator.

Certified Recovery Peer Advocate (CRPA) Training Program prepares students to become CRPAs.
