Update to PCMH Incentive Program

The January 2018 edition of the NYS Department of Health **Medicaid Update** includes an update on the PCMH Incentive Program. Effective May 1, 2018, in accordance with the 2018-2019 proposed State budget, NYS Medicaid is changing the reimbursement amounts for providers working at practices that are recognized as a Patient Centered Medical Home (PCMH) by the National Committee for Quality Assurance (NCQA). The revised policy applies to both Medicaid Managed Care (MMC) and Medicaid Fee-For-Service (FFS).

Specific details are in the **January 2018 Medicaid Update**. Additional guidance and educational materials will be published in the coming months outlining the new PCMH incentive payment amounts effective July 1, 2018.
