Request for Applications: Medicaid Redesign Team HHSHP

The NYS Department of Health (DOH) has announced the release of the Health Home Supportive Housing Program (HHSHP) Request for Applications (RFA).

DOH is seeking applications from community-based organizations to provide rental subsidies and non-medical services to homeless Medicaid members who are enrolled or enrolling in the state's Health Home Program. HHSHP is a previously funded program in effect from 10/1/2014-9/30/2018.

This program will serve those currently enrolled in the program and single individuals who are enrolled/enrolling in a Health Home and may include a certain number of families with minors under age 18. The total anticipated amount available for this procurement is up to \$500,000 annually. The contracts will run from 10/1/2018-9/30/2023.
